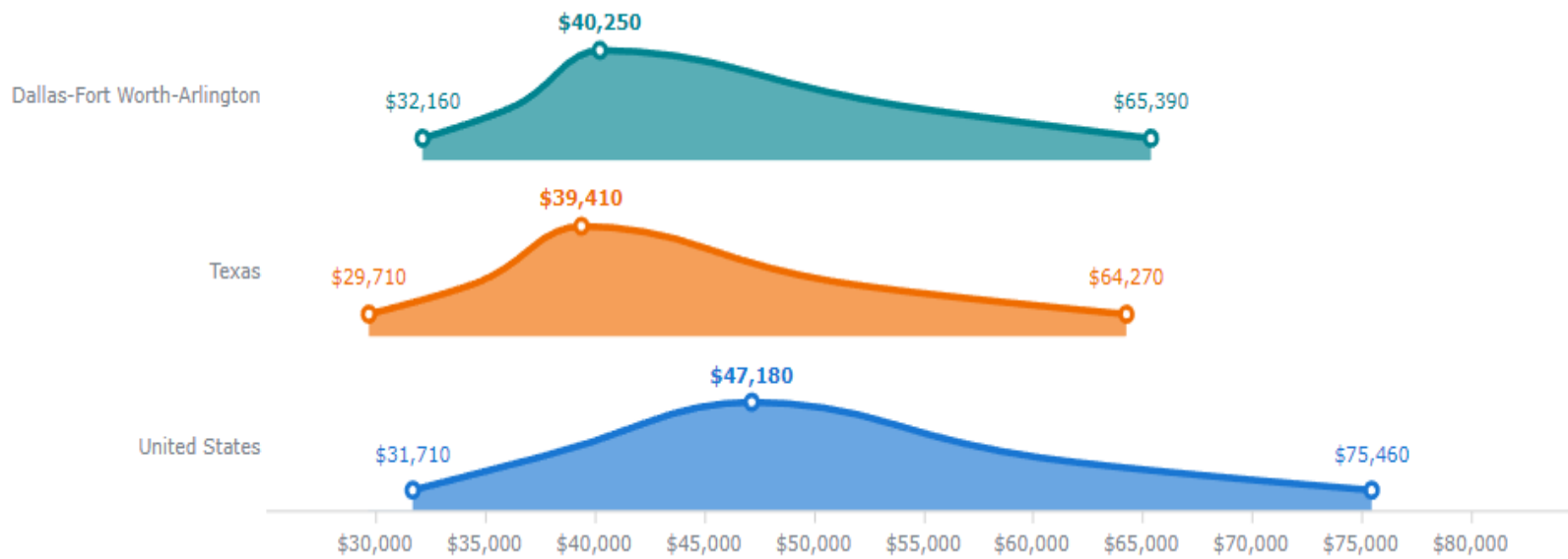

CAHIIM ACCREDITED PROGRAM

Commission on Accreditation for Health Informatics and Information Management Education (CAHIIM).

- CAHIIM is a nonprofit and globally recognized accrediting organization for health information management and health informatics education programs
- RHIT programs accredited by CAHIIM have voluntarily undergone a thorough review process and have met or exceeded CAHIIM's Board of Directors standards
- The curriculum is based on the AHIMA Foundation's curricular competencies for the Registered Health Information Technician (RHIT) credential and is approved by the Texas Higher Education.
- Upon successfully completing the coursework and the credentialing exam, facilitated by the American Health Information Management Association (AHIMA), the graduate may use the designation RHIT behind their professional signature.



The Health Information Management accreditor of Collin College is the Commission on Accreditation for Health Informatics and Information Management Education (CAHIIM). The College's accreditation for the Associate degree in Health Information Management has been reaffirmed through 2023.




CERTIFICATION

Most employers prefer to hire health information technicians who are credentialed, or they may expect applicants to earn a credential shortly after being hired.



REGISTERED HEALTH INFORMATION TECHNICIAN RHIT - CREDENTIAL

Professionals holding the RHIT credential are health information technicians who:

- Ensure the quality of medical records by verifying their completeness, accuracy, and proper entry into computer systems.
- Use computer applications to assemble and analyze patient data for the purpose of improving patient care or controlling costs.
- Often specialize in coding diagnoses and procedures in patient records for reimbursement and research.
- With experience, the RHIT credential holds solid potential for advancement to management positions, especially when combined with a bachelor's degree.

VALUE OF RHIT CREDENTIAL

- AHIMA certifications provide validation of professional competency to employers
- Credentialed professionals are ready to apply their skills and require less training than non-credentialed peers
- Expertise through credentialing reduces employers' exposure to fraud and abuse charges through precise, ethical management of health information
- Credentialed professionals receive **better compensation (\$\$)** from their employer
- Greater chance for advancement in one's chosen career

ELIGIBILITY REQUIREMENTS FOR APPLICATION TO THE AAS – HIM PROGRAM

- Admission to Collin College
- "C" or better in the pre-requisites courses
(HITT1305, HITT2430, BIOL2404, ENGL1301, and MATH1342)
- Minimum 2.5 Collin College GPA

AAS HIM PROGRAM ADMISSION STEPS

- Complete Collin College reading, writing, and mathematics assessments, placing at the College-Level (TSI Testing)
- Complete all pre-requisites for the HIM Program with a "C" or better (HITT1305, HITT2430, BIOL2404, ENGL1301, and MATH1342)
- Completion of the HIM Admission Packet by the deadline (2nd Friday in November for Spring consideration, the 2nd Friday in April for Summer consideration, and the 2nd Friday in June for Fall consideration.)
- Submit a 500-word essay, "Why Health Information?" The essay should demonstrate a working knowledge of health information management
- Two letters of recommendation from employers or teachers (not family or friends)

CONSIDERATIONS BEFORE YOU APPLY..

Immunizations, insurance, a drug screen, and a background check are required for HIM students to be placed in a Professional Practice Experience (PPE) setting. PPEs are Monday- Friday, 8 am - 5 pm. Students who work should make arrangements with their employers. More information regarding PPEs can be found under the "Current Students" heading.

*Note: It is strongly recommended that applicants self-disclose any potential infractions that may hinder PPE placement and career opportunities.

MEDICAL CODING AND BILLING CERTIFICATE

- Students completing the Medical Coding Billing Certificate are better prepared for coding credentialing exams such as
AHIMA's Certified Coding Associate (CCA) exam and the
American Academy of Professional Coders (AAPC) Certified Professional Coder (CPC®) exam.
- All courses completed with a minimum grade of "C" will transfer into the AAS – HIM Program if a student wishes to pursue an AAS degree

CERTIFICATE LEVEL 2 – DATA MANAGEMENT APPLICATIONS FOR HEALTHCARE 17 CREDIT HOURS

- Designed for the Health Information Management person and others interested in developing skills to assist with database management, queries, and reporting
- All courses completed with a minimum grade of “C” will transfer into the AAS – HIM Program if a student wishes to pursue an AAS degree

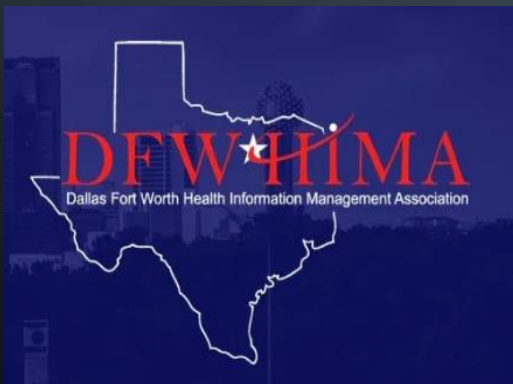

SCHOLARSHIPS



Each year the Texas Health Information Management Association (TxHiMA) awards several education scholarships to students who demonstrate academic achievement and commitment to the field of health information management in Texas. TxHiMA supports the professional development of individuals engaged in the undergraduate study of health information technology, health information management, and/or graduate study in health information management or related fields.



Two scholarships of \$1000 (one undergraduate and one graduate) will be presented to outstanding students **residing in the DFW area** who are currently enrolled in an accredited HIT/HIM program. Students must have a GPA of 3.0 for the undergraduate/3.5 for the graduate scholarship and continue their education during the next academic year (2022-2023).

- Another 60 hours will complete the requirements for a Bachelors Degree

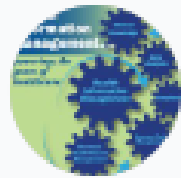
