

Clinical Immunization Requirements Collin College EMS Department

All submitted documentation must include the student's full name and the complete date of testing or administration (Month/Day/Year). If you have any questions, please email EMSInfo@Collin.edu.

MANDATORY: ALL immunization series or positive titers must be completed by Orientation

Ш	Measles, Mumps & Rubella- (MMR) - documentation of 2 MMR shots or a positive titer result for all three.
	<u>Varicella (Chicken Pox)</u> – documentation of 2 Varicella shots or a positive titer result .
	Hepatitis B (Hep B) – documentation of 3 doses of Hepatitis B shot, 2 doses of Heplisav-B shot, or positive titer
	<u>Tuberculosis (TB) test</u> - 1 of the following 3 TB tests completed within 12 months of your LAST possible clinical date.
	 TB Skin Test (TST). Documentation for the TST MUST include the date that the test was given (injected in the arm) & the date that the test was read (between 48 and 72 hours from the time the test was given). Test result must be NEGATIVE, and documentation must include a measurement in millimeters (mm), even if the measurement is 0
	 QuantiFERON®-TB Gold Plus (QFT-Plus) test or the T-SPOT®.TB (T-Spot) test. These are blood tests, so be sure to allow adequate time to receive the test result. Typically required for persons who have received a TB vaccine (BCG)
	<u>Tetanus, Diphtheria & Pertussis (TDaP)</u> – documentation must show a TDaP booster within the last <u>10 years</u> . Not to be confused with the DTaP or TD shot, they are not the same vaccine.
	Influenza (Flu) Shot - seasonal flu shots are required if a student will complete clinical shifts any month between October and May—early Fall to late Spring. Flu doses are <i>not</i> required for summer clinical courses.
	<u>COVID-19 Vaccination</u> – no longer required by our clinical partners, but being vaccinated is still highly encouraged. Please document any vaccinations received.

Health Insurance

- FRONT and BACK of health insurance card with student's name present
- If the student's name is not present, a Letter of Coverage Verification must also be submitted
- If you don't have insurance, Collin College will provide you with options at Orientation.

<u>CPR Certification</u> – American Heart Association Basic Life Support (BLS) for Healthcare Provider CPR. Our clinical partners **DO NOT** accept Red Cross or any other provider's courses. The expiration date on the card must extend past your expected program end date.

<u>Background Check and Random Urine Drug Screening</u> – a background check and urine drug screen are also required to participate in clinical experiences. Students will be given separate information on completing these.

<u>Professional Certification: For Paramedic students only</u> – upload a copy of your Texas Department of State Health Services (DSHS) EMT certification that is current/not expired.

Driver's License or ID Card – a copy of your state-issued driver's license or ID card.
