Budget Status Report as of 07/31/13

Mr. Hall presented the Budget Status Report as of July 31, 2013. Expenditures exceeded revenue by \$6,958,344 for the month of July. Year-to-date revenues exceeded expenditures by \$10,530,273.

Investment Schedule as of 07/31/13

Mr. Hall said that TexPool yielded .05% and TexStar .05% in July 2013. Investments totaled \$235,487,635 for the month. The Benchmark of a 3-Month Treasury Bill was .04% at the beginning of July 2013, and .04% at July 31, 2013.

- 1. President Israel thanked everyone in the college community for their hard work. He said it is always challenging to register the number of students that we register and provide the amount of service that the college is providing. He said improvements are still needed in some areas of customer service and customer relations and that our goal is to provide service consistent with our core values. Contact hours for fall 2013 are up by 1.5% at a time when enrollment is down at many community colleges in Texas. Dr. Israel said he applauds everyone for working very hard during a difficult time.

Professor Cronauer's *Sparrow* will appear with the Texas Shorts compilation program.
- 4. The August 16 All College Council's All College Day Silent Auction was a resounding success raising an outstanding \$7,348 for student scholarships. Thank you to all the members of the All College Council (ACC) for their leadership and to the vendors, faculty and staff who generously participated in the auction. Acknowledgements go to ACC Chair Carrie Bottoms, Silent Auction Co-Chairs Sarah Henderson and Holly Stone and many, many hard workers whose names will be listed in the President's monthly Board and College Update.
- 5. Three students from Collin's Respiratory Care Program have received Education Recognition Awards for Undergraduate Students from the American Respiratory Care Foundation. Student Stewart Morrison was the recipient of the Morton B. Duggan, Jr., Memorial Education Recognition Award and \$1,000; Kanokon Raksriaksorn received the Jimmy A. Young Memorial Education Recognition Award and \$1,000; and Tracy Bedar received the NBRC/AMP William W. Burgin, Jr., MD Education Recognition Award and \$2,500. The students will receive airfare, hotel accommodations, and complimentary admission to the American Association for Respiratory Care Convention to receive their awards on November 16 in Anaheim, California. This was no easy feat, each student was required to meet certain GPA requirements, write research papers, and provide letters of recommendation.

Collin also had two teams representing it at the Respiratory Care Trivia Bowl (aka Sputum Bowl) last month in Dallas. One team took first place while the other team made it to the final four. Trustee Arias thanked everyone for their work and commitment and said the Board of Trustees will keep trying to show how much they appreciate Collin's faculty, administrators and staff.

Trustee Wainwright gave his appreciation to Collin employees and jokingly advised them not to spend their 4% increase in one place.

Trustee Wurzman said she echoed the appreciation of the employees and said she was happy that the Board was able to approve the salary increases. She wished a happy and sweet new year for all those in the community who are celebrating the new year.

Chairman Hendricks said the Board of Trustees was putting the "money where the mouth is" in approving the 4% salary increases. He said the Board does not take the increase lightly because it knows the kind of support that it shows. He noted that the Board had given increases in some years when it was rough to do so, but that they recognize and understand that the employees make the college run as it does. He said he is speaking for the board members when he says they always have the best interest of the employees, students and community in mind.
