October 22, 2013

The Collin County Community College District ("Collin College" or "District") conducted its regular monthly Board of Trustees meeting on October 22, 2013, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Ms. Stacy Anne Arias, Dr. J. Robert Collins, Ms. Jenny McCall, Mr. Adrian Rodriguez, Mr. Tino Trujillo, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Trustee Andy Hardin was absent. Other attendees included District President Cary A. Israel, Collin College administrators, faculty, students, staff, community members, and vendor representatives.

2013-10-4 Ratification of the Retail Sales Agreement with Direct Energy Business, LLC.

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District ratifies the Retail Sales Agreement with Direct Energy Business, LLC to lock-in electricity rates effective May 1, 2014, through April 30, 2016, at the rate of \$0.0446 per kWh for each kilowatt-hour of electricity.

President Israel said that at its meeting of July 23, 2013, the Board of Trustees authorized the District President or his designee to monitor pricing offered by the Retail Electric Provider and lock-in pricing as deemed in the best interest of the District. The approval of this resolution ratifies the action taken as a result of the approval of Item 2013-7-4 on July 23, 2013. Dr. Israel said the agreement provides a rate that would result in a tremendous cost savings to the District. He introduced Brian Walker, Principal with Energy Edge Consulting, who was present to answer questions from the board members.

On motion of Mr. Rodriguez, second of Ms. Arias, the Board of Trustees of Collin County Community College District unanimously ratified the Retail Sales Agreement with Direct Energy Business, LLC to lock-in electricity rates effective May 1, 2014, through April 30, 2016, at the rate of \$0.0446 per kWh for each kilowatt-hour of electricity.

2013-10-5 Approval of Interlocal Agreement with Deep East Texas Worker's Compensation Insurance Fund

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the Interlocal Agreement between Collin County Community College District and Deep East Texas Worker's Compensation Insurance Fund for Worker's Compensation Insurance in the amount of \$121,900.00 each year for the years 2014-2015, 2015-2016, 2016-2017, 2017-2018, and 2018-2019.

President Israel said the Deep East Texas Worker's Compensation Insurance Fund had been in business for 32 years and works with many counties and school districts.

2013-10-9 Approval of Expenditure Reports for September 2013

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the Expenditure Reports for September 2013.

President Israel discussed expenditures for DP Software and Memberships during September 2013. The largest membership amount was \$78,907 for the Texas Association of Community Colleges (TACC).

After the lengthy discussion regarding the benefits of TACC membership, the Board of Trustees of Collin County Community College District unanimously approved the Expenditure Reports for September 2013 as presented.

Mr. Wainwright asked about the TACC membership dues that were paid in September for the upcoming year. Trustee Arias said the question was a good opportunity for a healthy discussion regarding maximizing Collin's benefit of membership. Chairman Hendricks and Dr. Collins stated that the organization was currently a presidents' organization more than a community college trustee organization. After lengthy discussion of some of the pros and cons of membership, Mr. Rodriguez said that discontinuing memberships with certain organizations sometimes results in them going against you and that the Board would need to consider whether it could have a negative impact. President Israel said this would be a topic for discussion of an action plan at a future retreat or meeting of the Board of Trustees.

2013-10-10 Approval of Bid Report for October 2013

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the Bid Report for October 2013.

On motion of Dr. Collins, seconded by Ms. Arias, the Board of Trustees of Collin County Community College District unanimously approved the Bid Report for October 2013 with the exception of Bid 3503.

On motion of Mr. Wainwright, second of Mr. Rodriguez, the Board of Trustees of Collin County Community College District unanimously approved Bid Item 3503 of the October 2013 Bid Report. The approval of Bid 3503 was separated from the approval of the other bid items because it was written to show that the contract would result in revenue to the District and not an expenditure. Vice President/CFO Ralph Hall said that in the future the item would be presented as an agenda item on its own.

In answer to Mr. Rodriguez's questions regarding the District's loss ratio on property and casualty and why the college does not take bids upon renewing, Dot Hedman from Roach, Howard, Smith & Barton said there was only one claim and that was a pending claim on the EEOC educator's liability. She said she did not have the information at hand, but would be glad to provide it. Ms. Hedman said the college does go out for bid periodically and that she went out to six different markets on this bid. However, she said many companies would quit responding if they felt the college was just shopping for rates each year. She said Collin's policy went up this year because of a 10% increase in property value. However, at a rate of 3.5 cents, Ms. Hedman said it was far less than any other policies she

had seen written recently because the companies know that Collin is a profitable organization for them. She said that Roach, Howard, Smith & Barton are advocates for the college and that they do not work for the companies, but rather for Collin.

Chairman Hendricks said often times 15 or 20 companies or individuals pick up bid packets, but only three or four actually bid. He proposed a pilot from January through April to track the packets sent out and find out why they were not bid. President Israel said it could be done utilizing Survey Monkey and a small questionnaire. Vice President Hall said he had a conversation with a reputable mechanical contractor who said they did not bid because they were always higher than the other bidders and knew they would not get the contract. Mr. Hall said the vendor has to be competitive and that may be the reason some are not bidding. Chairman Hendricks said an anonymous survey could be helpful in critiquing the District's bidding process.

- 2. Collin College students, faculty, and staff donated an outstanding 635 boxes of food and supplies and \$355 in cash in this year's Fall Harvest Food Drive. This is quite a step up from last year's 347 boxes donated through the All College Council initiative. We appreciate all who participated and made a difference for those in our communities who are shut-in or cannot afford certain food and supply items. Thank you to everyone for this wonderful outpouring of generosity and participation. Special acknowledgement goes to the members of the All College Council, its chair Sarah Henderson, and campus coordinators at CHEC Sarah Henderson and Vickie Stone; CPC Rhonda Bolton and Holly Stone; CYC Caroline Langton; PRC Carrie Bottoms and Jill Braziel; and SCC Brett Haduch and Ruth Payton. Collin's Core Value of Service and Involvement shines brightly through this initiative.
- 3. Ed Buchanan, Program Director from the Texas Higher Education Coordinating Board, has placed Collin's Nursing Program at the top of the list of nursing programs in the entire State of Texas. Nursing Director Donna Hatch has been notified that Collin is the only community college in Texas to receive the nursing shortage reduction program grant for eight (8) consecutive years since the grant was first created in 2006 by the Legislature and Texas Higher Education Coordinating Board. We appreciate Senior District VP Dr. Colleen Smith, Vice President/Provost Sherry Schumann, Dean Abe Johnson, Director Hatch, and the faculty and staff of the nursing program on this accomplishment.
- 4. In addition, Director Hatch has been elected to serve on the Advisory Board for the North Texas Organization of Nursing Executives (N-TONE) for the 2013-2014 year. N-TONE is for area hospital high-level nursing executives; serving on the board will assist Collin in maintaining strong affiliations with area hospitals and assisting in policy making in the best interest of our nursing students and graduates.

- 5. Collin will host the Mock Trial Invitational in the Mock Trial Room at the Spring Creek Campus October 25-27. Currently, 12 schools and over 125 students are scheduled to participate. They include:

President Israel said he was honored to join motivational speakers and civic leaders in taking the stage to educate and inspire men in a pledge to stop domestic violence. Key supporters included Plano Mayor Harry LaRosiliere, Frisco Mayor Maher Maso, Allen Mayor Stephen Terrell, McKinney Mayor Brian Loughmiller, Collin County District Attorney Greg Willis, State Representative Jeff Leach, and area police and fire chiefs. We appreciate Vice President/Provost Mary McRae, Vice President Barbara Money, and Dr. Linda Qualia, Director of Counseling Services, for their support and involvement of this worthy initiative.
- 7. Professor of Developmental Reading Pam Sawyer represented Collin College as the recipient of the Gladys R. Shaw Professional Development Award at the College Academic Support Programs' (CASP) recent conference in Amarillo. CASP is part of the Texas College Reading and Learning Association.
- 8. Collin College has once again been named a top military-friendly school by *Military Advanced Education* (MAE). We appreciate the efforts by Vice President/Provost Brenda Kihl, Assistant Director of Financial Aid/Veteran Affairs Arianna Gray, Professor Meredith Martin, Associate Vice President Tom Martin, Associate Registrar Vickie Woolverton and all others involved in making this happen.

- 9. At the fall 2013 annual meeting of the Texas Council of Academic Libraries, Executive Director of the Spring Creek Campus Library Linda Kyprios was elected to serve as the at-large representative to the Executive Council for the Texas Council of Community and Junior College Libraries.
- 10. The Developmental Education Division reports that the fourth Annual Study Skills Conference Day held on September 27 was a huge success. Thirty-seven (37) seminars were offered across the District led by faculty and staff presenters featuring topics on practical study skills, college resources, and personal development. A record breaking attendance of 749 students participated in this year's conference day. Interim Dean Jim Barko says the written comments from students were extremely positive. Special thanks go out to Senior District VP Dr. Colleen Smith, Vice President/Provost Mary McRae, Dean Barko, the Developmental Education faculty and staff and the presenters from the ACCESS Office, Counseling Services, and the Library. Special recognition goes to Professor Linda Kapocsi for her leadership in organizing such a successful even in her first year as faculty coordinator.
- 11. Professor of Biology Rebecca Orr has been invited to present two talks and sit as a panel participant at Ohio State University in November. She will be joined by Dr. Matt Stolzfus of the Ohio State University and Dr. Brian Lukoff of Harvard University.
- 12. Collin's AAA rating has been affirmed with Standard and Poor's Ratings Services with a stable outlook on general obligation (GO) bonds. In its rational, S&P said, "The rating reflects our opinion of the district's inclusion in the deep and diverse Dallas-Fort Worth metropolitan statistical area (MSA), boosting wealth and income levels; very strong financial position, coupled with good management practices; and diverse revenue streams with significant revenue-raising flexibility." We appreciate the Board's stewardship that resulted in this affirmation.
- 13. In March 2012, the Collin Association for Sustainable Efforts (CASE), helped implement a partnership with the World Wear Project to locate shoe and clothing collection boxes in the parking lots of CPC, PRC and SCC. In doing so, the Collin College Foundation receives a monetary donation for every pound collected. Since the beginning of the initiative, \$8,313.75 has been raised for Collin student scholarships. We appreciate the members of CASE and its faculty advisors Professors Martha Chalhoub, Heinrick Goetz and Clay Randall for their leadership on this initiative.

The Board announced the following:

Referring to the discussion regarding the TACC membership, Trustee Wurzman said it was good for the audience to see such a lively discussion by the board members. She said if Washington worked so well, there would not be problems. Ms. Wurzman thanked everyone for their work.

Trustee Rodriguez congratulated the staff and faculty and said it was great to hear the wonderful news in the President's Report every month. He said that on Thursday, the LULAC organization is honoring the Lynn Ojeda, Principal at Williams High School, as the Educator of the Year at its annual scholarship banquet. Mr. Rodriguez said Ms. Ojeda is a wonderful friend and that there is no better person to be helping with the Health Sciences Academy.

Chairman Hendricks said he did some calculating on the \$52,000 raised by the *Employee Giving Campaign*. He said his figures show that if the funds were invested in the college's custodial account it would equate to about a \$1.4 million investment. Chair Hendricks said that if he had a hat on, he would take it off to everyone who participated in the campaign.
