# **Meeting Minutes**

November 26, 2013

The Collin County Community College District ("Collin College" or "District") conducted its regular monthly Board of Trustees meeting on November 26, 2013, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Ms. Stacy Anne Arias, Dr. J. Robert Collins, Mr. Andy Hardin, Ms. Jenny McCall, and Mr. Adrian Rodriguez. Trustees Tino Trujillo, Larry Wainwright, and Nancy Wurzman were absent. Other attendees included District President Cary A. Israel, Collin College administrators, faculty, students, staff, community members, and vendor representatives.

#### **CALL TO ORDER**

Chairman Hendricks called the November 26, 2013, meeting of the Board of Trustees of Collin County Community College District to order at 5:45 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

#### **PUBLIC COMMENTS**

Jo Via of the Plano Balloon Festival presented the Board of Trustees with a check for \$23,000 for partnering in the 2013 festival. She thanked the trustees for being instrumental in the success of the annual event. President Israel said that 95,410 people attended this year's festival. He said the college does close the Spring Creek Campus for the event, but it is for a good cause. With this year's check, 23 students will be able to attend the college for one semester. Dr. Israel noted that non-profit service providers and food concessionaires raised over \$171,500 for their organizations this year.

He has been actively engaged by serving on the Council on Excellence, Sabbatical Leave Task Force, and numerous shared governance committees at the college. Additionally, he has served the greater community by designing murals for the Douglas Community Center, display panels for the Texas Hispanic Genaelogical Society and providing leadership to the Plano Art Association, Texas Visual Arts Association, and others. ## 2013-11-3 President's Status Report on Strategic Goals 2013-2014

BE IT RESOLVED, that the President presented the Status Report of the Strategic Goals for 2013-2014 to the Board of Trustees of Collin County Community College District. No action was required nor taken.

# Strategic Goal 1: Improve academic success by implementing strategies for completion.

Enhance academic advising to assist students in formulating a personalized degree.

- Degree Works software tested.
- QEP currently researching academic advising.

Develop systematic academic advising across the district to include faculty advising as part of college service.

 Systematic faculty-based advising supported by Academic Advising tested in Developmental Education.

Increase academic advisor training and enhance training materials.

- Increased training opportunities.
- Held two Saturday training/update meetings in July for all FT and PT advisors.
- Revamped academic advising training manual.

Develop and market clear pathways for student completion.

Marketing plans will be created based on development of pathways.

Enhance course placement assessment by implementing new Texas Success Initiative Assessment.

- Review TSI student placement.
- Review DE advising for enhanced student placement strategies.

Develop system that requires orientation prior to course registration.

- Software has been tested and will be requested through budget process.
- Plans to submit proposals to Leadership Team for review/approval.
- Purchase software to coordinate registration and house online orientation modules.

Improve training for financial aid staff to include review of past errors and data on response times.

- Bi-monthly meetings with financial aid leadership with increased communication.
- Increase access to webinars through NASFAA.

- Create individualized professional development plan for each financial aid employee.
- Establish a formal review process for financial aid processes.
   Coordinate all district-wide academic support service to ensure consistency across the district: Tutoring, Writing Center, Math and Science Labs, Testing Center and Academic Advising.
- Once QEP and mandatory orientation finalized, these services will be reviewed.

# Strategic Goal 2: Provide access to innovative higher education programs that prepare students for constantly changing academic, societal and career/workplace opportunities.

New programs will be developed in key workforce and academic areas.

- The Certified Veterinary Assistant, Level 1 (CVA-1) program was approved and implemented in Continuing Education.
- 14 students registered in the first cohort.
- The CVA-1 program will be offered in CE three times a year.
- The State of Texas through the Texas Department of Health Services approved Collin College Continuing Education to be a training center for Radiology Training.
- Other planned new healthcare classes for fall 2014 are Cardiovascular Sonography (CVS), Medical Secretary Certificate Series, and Dialysis Technician.
- Exploring Diagnostic Sonography, Occupational Therapy Assistant, and Radiologic Technician.
- Focus group for Nursing or Specialty Certificate has been identified.
- Baylor Healthcare System and HCA System have contacted Collin to co-develop this certificate.
- Course offerings in Fine Arts at PRC and CPC have been expanded.
- In the future, the Division of Fine Arts will expand at CPC (e.g. guitar and voice) and offer studio arts (e.g. drawing, watercolor, life drawing, painting.)
- Current conference center facilities will be modified into a performance space (i.e. blackbox) for theatre/dance courses, and a ceramics area will be developed.

Collin College will be positioned as a leader in refining employment skills for advanced workplace opportunities and workforce training in a global market.

- Offering XenDesktop class.
- Cloud courses in Vmware vSphere enrollments totaled 115.
- Workforce training in Basic Electrical Wiring.
- Interior Design Concepts certificate series developed 158 enrollments.
- Truck Driving 33 enrollments to date.

Enhance dual credit options with ISDs.

- A new dual credit academy in STEM fields is currently being developed.
- Dual credit offerings at Prosper High School have been offered in a hybrid format to accommodate Prosper ISD's bell schedule.
- Frisco ISD has requested the expansion of dual credit offerings. Technical dual credit tracks in STEM CTE fields have been established with five area ISDs including Allen, Frisco, McKinney, Prosper and Wylie.

Strategic Goal 3: Engage faculty, students and staff in improving a district-wide culture of adherence to the Collin College Core Values. "We have a passion for: Learning; Service and Involvement; Creativity and Innovation; Academic Excellence; Dignity and Respect; Integrity."

Enhance customer service training throughout the college to improve students' experiences in Collin College.

- Chick-fil-A McKinney customer service training conducted for all FT academic advisors by franchise owner Don Westback.
- A topic for All College Day in January 2014 will be "Improving the Student Experience." Analysis of the results will lead to appropriate training to enhance the student experience, e.g. telephone etiquette, active listening skills, conflict resolution.
- New guidelines for greeting and treating customers professionally and courteously have been developed.
- Held conference call with Cuyahoga Community College Director of College Information Center. The center handles all phone calls, web chat, and emails for the district in support of enrollment services.
- Student Development team visited UT Dallas to review their automated Wait System for registration and advising.
- Review of several automated wait systems currently in use.
- Webinar over Ivey Tech Community College District, Indiana, Call Center. They
  described the use of Black Board administrative services to establish a 24/7 help
  desk and comprehensive FAQ system for all inquiries. Options continue to be explored.

Utilize the service and involvement of staff and faculty committee with participation across the district to develop the compliance document and the QEP.

- The QEP Development Team for the District was selected and announced. The Team represents a valid cross section of participants from faculty, staff, and administrators.
- Committees comprised of over 900 staff and faculty met on All College Planning Day to provide input to the QEP Development Team.
- Development Team has met to begin development of the institutional QEP plan.
   Four sub-committees were formed: Data Research, Literature Review, External Practices Research, and Technology Research.
- Initial QEP information has been sent to SACSCOC Vice President for his review and recommendations.

Create and post brief videos that describe various Collin processes in short, easy to view formats (e.g. YouTube).

- Active Shooter video produced and distributed to students, faculty and staff for procedures in a crisis.
- The video has been viewed more than 4,000 times and won a Gold Medallion award from NCMPR.
- Process videos created for new student orientation on financial aid, counseling services, the Center for Scholarly and Civic Engagement and athletics.
- Public Relations will create and distribute a video to students showing how to forward CougarMail to their personal mail accounts to encourage better monitoring of CougarMail.

# Strategic Goal 4: Enhance the College's presence in the community by increasing awareness, cultivating relationships, building partnerships and developing resources to respond to current and future needs.

The college's overall approval ratings in the community surveys will be improved including perceptions of academic quality and contributions to the local economy.

- A new (four-year) marketing plan was developed and implementation is in process.
- New billboard on North Dallas Tollway purchased, yielding 1.7 million impressions per month.
- Special edition of newsletter published saluting academic excellence direct mailed to 300,000 households and emailed to VIP contacts.
- Video produced using Academic Excellence infographic from newsletter and distributed in electronic newsletter on YouTube (757 views in two months) and in a movie commercial scheduled for December 2013.
- Spotify, YouTube and Instagram to be evaluated for sponsored content and/or ads.
- Full-page Academic Excellence ad scheduled for Dallas Morning News in November 2013.
- Faculty experts in cybersecurity featured on network TV newscast October 30 demonstrating academic excellence of Collin College.
- New home page designed and CMS migration in process for December 2013 launch.
- Publicized opening of SCC library with feature story in *Plano Profile* as well as news releases and *Connection* story.
- iHeart Radio pilot ad campaign in process. Pandora proposal under evaluation.
- New electronic version of the community newsletter was launched in fall 2012, optimized for social media and with a new VIP and key media distribution list.
- LinkedIn "universities" page created and has 19,168 followers. LinkedIn "companies" page re-claimed/updated and now has 1,961 followers.
- "Collin College" Twitter handle reclaimed.
- Co-op billboard proposed to CHEC partners but partners did not reach consensus to proceed.

Gifts and grants to the college and foundation will be increased.

- A four-year plan has been created, approved by the foundation board of directors and implemented by the foundation staff.
- Total annual revenue for 2012-2013 academic year was \$1.052 million, representing a 78.8% increase in total revenues from the prior academic year.
- The Collin County and Texas Trivia Night was a sell-out and successfully raised \$231,000 gross (\$207,000 net) for student scholarships.
- The goal for 2014 will be \$237,000.
- The next event will be held February 22, 2014.
- The Foundation has secured two new \$100,000 gifts.
- Additionally, a new donor has emerged who may donate \$1 \$2 million.

Implement an alumni program.

- Information to graduates will be the first step.
- Interest among alumni is being assessed with the goal of identifying a desirable structure as well as return to alumni.
- Plans are shaping up to kick off an alumni group in 2015 to coincide with the 30<sup>th</sup> anniversary of the college.

# <u>2013-11-6 Approval to Not Participate in the State Employee Charitable</u> Contribution Program

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves an action to not participate in the State Employee Charitable Contribution Program.

President Israel said it was his recommendation that the college not participate in the State Employee Charitable Contribution Program for several reasons. He said those giving a donation through SECC do not receive a tax receipt, administration costs are 10%, and gifts are not decided by the college. He also discussed the Sunset Commission's review of SECC. Dr. Israel added that by participating in the Collin Foundation's 2013 *Lift Up* Campaign, employees saw 100% of their dollars go directly to scholarships with no administrative fees.

On motion of Mr. Rodriguez, seconded by Dr. Collins, the Board of Trustees of Collin County Community College District unanimously approved an action to not participate in the State Employee Charitable Contribution Program.

# 2013-11-7 Approval of Resolution Assigning Votes for the Board of Directors of the Central Appraisal District of Collin County

WHEREAS, Collin County Community College District has 192 votes to cast for the Board of Directors of the Central Appraisal District of Collin County, AND

WHEREAS, Section 6.03 (g) of the State Property Tax Code requires the action to be taken by resolution and returned to the Chief Appraiser before December 15, 2013, THEREFORE

BE IT RESOLVED, that the Board of Trustees of Collin County Community College District on November 26, 2013, approves the casting of its 192 votes on the Official Ballot for the Board of Directors of the Central Appraisal District of Collin County.

Dr. Collins said there was a lack of information regarding the candidates. Chairman Hendricks commented that time did not allow for much research this year, but the board would know to do so in the future. Mr. Hardin proposed that the two new nominees each receive one vote and that the remainder of the 192 votes be divided among the five incumbent with 38 votes each.

## 2013-11-8 Approval of Blanket Purchase Agreement with The Hon Company

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of the Collin County Community College District approves the Blanket Purchase Agreement by and between The Hon Company ("HON") and Collin County Community College District (the "District") through the Collin County Government Purchaser's Forum.

President Israel said this is an annual renewal for the HON Purchase Order. The agreement allows the District to acquire HON commercial products and services directly from HON, with the assistance of authorized servicing dealers, using Tier 9 pricing, terms and conditions set forth in the HON Federal Supply Schedule Contract GS-28F-8047H, by and between HON and the General Services Administration (GSA).

The Texas Procurement and Support Services (TPASS) has established the use of Texas multiple award schedule (TXMAS) contracts that have been developed from contracts that have been competitively awarded by the federal government or any other governmental entity of any state. The prices reflected on General Services Administration schedule contracts are the most favored customer prices. As a cooperative member of the TPASS Cooperative Purchasing Program, the District is authorized to utilize TXMAS contracts as an alternative purchasing method.

On motion of Mr. Rodriguez, second of Ms. Arias, the Board of Trustees of Collin County Community College District unanimously approved the Blanket Purchase Agreement by and between The Hon Company ("HON") and Collin County Community College District (the "District") through the Collin County Government Purchaser's Forum.

# 2013-11-9 Approval of Interlocal Agreeement with Texas Community College Cooperative Purchasing Network

WHEREAS, Collin County Community College District, pursuant to the authority granted by Title 7, Chapter 791 Interlocal Cooperation Contracts Act of the Texas Government Code, as amended, desires to participate in the described Texas Community College Cooperative Purchasing Network. Said Network to be coordinated and administered by the Texas Association of Community Colleges; AND

WHEREAS, Collin County Community College District is of the opinion that participation in this program will provide the best value to the taxpayers of this district through the anticipated savings to be realized; AND

WHEREAS, the fees for the Cooperative as stated in the Interlocal Agreement shall be paid to the Texas Association of Community Colleges for reimbursement of expenses incurred in the administration of the Cooperative; NOW THEREFORE

#### Investment Schedule as of 10/31/13

Investments for the month of October totaled \$222,64,552 with TexPool paying 0.05% and TexStar 0.04%. The U.S. Treasury benchmark was .02% on October 1, 2013, and .04% on October 31, 2013.

Professor Ceilidh Charleson-Jennings and President Israel traveled to Washington D.C. on November 14 where she received her award in a luncheon ceremony that was followed by a congressional reception. We are very proud of Professor Charleson-Jennings' achievement that marks the sixth Carnegie Professor of the Year for Collin College, a feat unmatched by any college or university in the state of Texas.
- 4. News about Professor Charles-Jennings made several newspapers including the front page of the *Plano Star Courier*. It also features an ad with all six Carnegie winners. The six professors of the year are representative of the entire faculty throughout the Collin College District.

- 5. New full-time Professor of English Sean Ferrier-Watson recently defended his dissertation, "Fearful Beginnings: The Evolution of the American Ghost Story for Children" at Texas A&M-Commerce. Additionally, Professor Ferrier-Watson presented "The Rise of The Specter: The Beginnings of The Supernatural Ghost for Children" at the 2013 American Studies Association of Texas Conference at Baylor and was awarded first prize for the presentation at the conference's annual presentation competition.
- 6. Professor of Foreign Languages/Arabic Sean Geraghty, a doctoral student at the University of Wisconsin-Madison, recently defended his dissertation, "Classically Modern: <sup>c</sup>Abd al-Qāhir al-Jurjānī's Rubric for the Analysis and Interpretation of Comparative Imagery."
- 7.
