Meeting Minutes

April 22, 2014

The Collin County Community College District ("Collin College" or "District") conducted its regular monthly Board of Trustees meeting on April 22, 2014, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Ms. Stacy Anne Arias, Dr. J. Robert Collins, Mr. Andy Hardin, Ms. Jenny McCall, Mr. Adrian Rodriguez, Mr. Tino Trujillo, and Mr. Larry Wainwright. Trustee Nancy Wurzman was absent. Other attendees included District President Cary A. Israel, Collin College administrators, faculty, students, staff, community members, and vendor representatives.

CALL TO ORDER

Chairman Hendricks called the April 22, 2014, meeting of the Board of Trustees of Collin County Community College District to order at 5:33 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

ADJOURNMENT TO CLOSED OR EXECUTIVE SESSION

Chairman Hendricks recessed the meeting to closed session at 5:34 p.m. in Room 135, Board Conference Room, as authorized by Article 551.001, Texas Government Code, Sections 551.071 Consultations with Attorney; 551.072 Deliberations about Real Property; and 551.074 Personnel Matters.

OPEN SESSION

Chairman Hendricks reconvened the meeting at 7:10 p.m. in Boardroom 139 and welcomed those in attendance. Chairman Hendricks called on Shirley Harmon, Executive Assistant to the President/Secretary to the Board of Trustees, to certify posting of the notice of the meeting.

Ms. Harmon certified the notice of the April 22, 2014, Collin County Community College District Board of Trustees meeting was posted according to Article 551.001 of the Texas Government Code.

Chairman Hendricks led the pledges of allegiance to the American and Texas flags.

APPROVAL OF THE MINUTES OF THE MARCH 25, 2014, REGULAR MEETING OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT BOARD OF TRUSTEES On motion of Mr. Wainwright, seconded by Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved the minutes of its March 25, 2014, regular meeting.

PUBLIC COMMENTS

Trustee Larry Wainwright introduced the new Superintendent for Allen ISD Lance Hindt. Dr. Hindt said he looked forward to working with Collin College in providing opportunities for the students of Collin and bordering counties.

PRESENTATIONS AND RECOGNITION:

The Board of Trustees and President Israel recognized Collin's exemplary Phi Theta Kappa (PTK) team for its international awards and honors, the recipient of the 2014 Jack Kent Cooke Scholarship, and the President of Collin's Student Government Association. Chairman Hendricks and Vice Chair Arias greeted each recipient and presented them with gifts.

Students Michelle Davis and Lilliam Alexa Acosta were recognized and honored as members of the All-USA Academic Team by Phi Theta Kappa International Honor Society. Only 20 students from more than 1,700 nominations were selected for this prestigious honor. As the state's top scorer in the All-USA competition, Ms. Davis was also recognized as the 2014 Coca Cola New Century Scholar for Texas. In addition, she was named the inaugural 2014 Pierce Scholar. *USA Today* interviewed Michelle for a feature story on behalf of the All-USA Academic Team, and she gave an eloquent speech at the American Association of Community College's Presidential Brunch in Washington, D.C. last week. President Israel noted that Michelle had the highest score in the United States.

In addition to being named All-USA Academic, Ms. Acosta was recognized as the national Guistwhite Scholar.

Michelle and Alexa were presented with college medallions, framed resolutions from the Board of Trustees and President Israel, a note from U.S. Senator John Cornyn, a letter and certificate from Texas Senator Ken Paxton, and a large Collin College gift basket.

Student Janice Hitchcock was honored as one of 30 members of Phi Theta Kappa internationally to receive the 2014 Distinguished Chapter Member Award. She was presented with a college medallion and gift basket.

Faculty advisors Drs. Jessica Hargis and Garry Evans were honored as recipients of the PTK Paragon Award for New Advisors. They were presented with a college medallion and gift basket.

Dr. Terry Hockenbrough, Director of the Center for Scholarly and Civic Engagement, was honored as a Distinguished College Administrator. She was presented with a college medallion and gift basket.

Collin's Phi Theta Kappa Alpha Mu Tau Chapter officers received the Distinguished Officer Team Award. They were one of 30 recognized from 1,285 Chapters worldwide. A framed college medallion was presented to the chapter as well as individual gift baskets to each officer.

Moriah Walton was recognized as this year's Jack Kent Cooke Scholarship recipient. Moriah was one of only 85 recipients from 3,705 applications received from 48 states, two U.S. territories and the District of Columbia. She will receive as much as \$30,000 per year for up to three years to complete her bachelor's degree at an accredited college or university of her choice. President Israel said this is a three-peat for Collin College. Ms. Walton was presented with a resolution from the Board of Trustees; she received a college medallion and other gifts at an earlier reception.

Student Government Association President Joel Mason was recognized for his leadership. He has been elected to serve as President of the Texas Student Government Association beginning in fall 2014. Collin College has never had a student serve in this statewide capacity. Mr. Mason was presented with a gift basket.

President Israel said the college is very proud of these accomplishments and thanked the students and advisors for choosing Collin College and for promoting excellence. He noted that Collin's Alpha Mu Tau chapter of PTK has been a 5-Star Chapter for the tenth year in a row and said it is very difficult to sustain this type of excellence. He said it speaks very well of the board, students, faculty and staff of the District. Dr. Israel added that he has been associated with Phi Theta Kappa for 20 years and has never before seen a college with so many accomplishments.

Additionally, Dr. Israel said the District would miss the expertise, quality teaching, leadership and hard work of Professors Robert Meeks and Mary Jane Tobaben. We extend our thanks for the quality service and extraordinary help provided by Program Director Carol Luckock and Operator/ Maintenance Technology Supervisor Gilbert Padron. President Israel wished all of them the very best in retirement and said they would be greatly missed.

In answer to Dr. Collins' questions, Chief Information Systems Officer David Hoyt said that the District needs to move to the next version of the portal and, since it is a shift in technology, we are contracting with the vendor to provide training. Mr. Hoyt said the college owns the software so this approval is for training and implementation services. He said there is new hardware involved, but the college already has it. In answer to Mr. Rodriguez' question, Mr. Hoyt said the exclusions in the contract are things that the college does not use.

In answer to Mr. Wainwright's question, Vice President/CFO Ralph Hall said the services to be provided would make sure that every part of the HVAC, fire alarm, and other systems work in tandem throughout the entire building. Mr. Hall said a lot of research goes into air balancing and that it saves the District money in the long run.

President Israel said that with Items 5 and 6, there is nothing the companies can do at this time. However, it is good to be prepared and locked into pricing. There critical need is to construct the parking so that it can be utilized during the staging of the project. A maximum guaranteed price for the parking will be presented to the Board of Trustees at its May 2014 meeting.

Director of Purchasing Cindy White and Chief Information Systems Officer David Hoyt said the bid was for 48 of the top items the college purchases annually for projectors and various media equipment. Mr. Hoyt said the bid was reviewed by the product standards used throughout the District and whether vendors are able to provide all phases of services, such as providing the equipment, installation, training, and/or other services. members regarding the information on this and other bids, President Israel said he would meet with Vice President/CFO Hall and devise the rational to be used with bid items for the next board meeting.

On motion of Dr. Collins, seconded by Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved the Bid Report as presented with the exception of Bid 3668.

On motion of Mr. Hardin, seconded by Dr. Collins, the Board of Trustees of Collin County Community College District unanimously agreed to table consideration of Bid 3668 until sufficient information could be provided for the board's review.

INFORMATION REPORTS

Ralph Hall, District Vice President of Administrative Services/CFO presented the following information reports:

Budget Status Report as of 03/31/14

For the month ending March 31, 2014, expenditures exceeded revenue by \$4,431,638. However, year-to-date revenue exceeded expenditures by \$44,472,767.

Investment Schedule as of 03/31/14

Investments for the month of March totaled \$268,343,237 with TexPool paying .03% and and TexStar paying 0.04%. Two Fannie Mae's were paying .12%. The U.S. Treasury benchmark was .05% on March 1, 2014, and .05% on March 31, 2014. A short-term certificate of deposit with Bank of America is paying .13%.

PRESIDENT'S AND BOARD ANNOUNCEMENTS

Comments on: Workshops, Seminars, and Conferences taking place at the College; Awards Received; Accomplishments, Appointments at the Local, State, and National Level; Published Articles and Newspaper Reports; College Reports/Metrics and Upcoming Events.

President Israel announced the following:

1. We received notification that our Respiratory Care program will receive the *Distinguished RRT Credentialing Success Award* from the Commission on Accreditation for Respiratory Care (CoARC). With two awards in a row, this is quite extraordinary. Programs selected for this award were required to have three or more years of outcomes data; hold accreditation without a progress report; document RRT credentialing success of 90% or above; and meet or exceed established CoARC thresholds for CRD credentialing success, attrition and positive (job) placement. A total of 49 out of 441 accredited programs received this distinguished honor including top universities and colleges. The certificate will be awarded in July at the organization's summer forum in Marco Island, Florida. This award reflects the hard work and leadership of District Vice President Colleen Smith, Vice President/Provost Sherry Schumann, Dean Abe Johnson, and especially Program Director Araceli (Celi) Solis and the faculty and staff of our Respiratory Care program.

- 2. For the third time in Collin's history, one of our students has finished first out of 1,012 participants in the Southwest Region for the Student Math League competition, sponsored by the American Mathematical Association for Two-Year Colleges (AMATYC). Student Vu Phan won the competition. He beat out students from Lone Star, Arizona Western, Tarrant, Austin, Glendale and other colleges. Student Seungjoon Kim finished third with an outstanding score. Mr. Phan and Mr. Kim will receive Collin College scholarship awards. Mr. Phan will also be honored by the Texas branch, TexMATYC as the highest-scoring student in Texas. The contest combines two scores, one from the fall competition and one from the spring. Congratulations to our fantastic students Vu and Seungjoon, District Vice President Colleen Smith, Vice President/Provost Mary McRae, Dean Cameron Neal, and especially Faculty Advisor Ed Bock and Collin's entire fantastic math faculty.
- 3. The Collin College Nursing Program received the Nursing Shortage Reduction Program grant in the amount of \$350,000. Out of a total of 111 associate and baccalaureate programs in Texas, 21 colleges and universities qualified for this grant. Collin's nursing program has the highest graduation rate at 98%. Acknowledgments go to District Vice President Colleen Smith, Vice President/Provost Sherry Schumann, Dean Abe Johnson, and especially Dean of Nursing Donna Hatch and the faculty and staff of the nursing program.
- 4. Professor of Theatre Gail Cronauer has been busy, or as she says, "I'm Ba-ack!" On April 2, she guest starred in an episode of Revolution on NBC, then on April 7, she appeared in Dallas on TNT. This is very exciting.
- 5. Congratulations to Collin College Dance students and Professor Tiffanee Arnold on earning Gala Selections at this year's South Region of the American College Dance Festival Conference in Little Rock, Arkansas. Out of 36 adjudicated works, Collin was one of 12 works selected for the Gala Concert. This makes a total of eight Gala Selections for Collin College Dance and six Galas for Professor Arnold's choreography. Kudos to our 13 participating students, Professor Arnold and her fellow faculty members Meghan Cardwell-Wilson, Courtney Mulcahy and Lesley Snelson.
- 6.
