CALL TO ORDER

Mr. Rodriguez asked that, since there is an important legislative session coming up in spring 2015, the committee take into consideration someone who has the legislative experience to help the board.

2014-6-6 First Reading of Board (Local) Policies

WHEREAS, following a thorough review by administration of Board local policies proposed by the Texas Association of School Boards Policy Services (TASB), NOW THEREFORE

President Israel said the Organization, Education and Policy Committee chaired by Larry Wainwright reviewed the policies at its meeting earlier in the day. He highlighted several recommended changes to the policies including the following revisions:

BD would require two or more board members to propose an agenda item before it is placed on the agenda.

CR ensures compliance with the requirements of the Digital Millennium Copyright Act. (DMCA) and the Higher Education Opportunity Act. It further identifies David Hoyt, Chief Information Systems Officer, as the Designated Agent for the DMCA.

DAA deletes reference to the Texas Educational Opportunity Plan since it no longer exists and proposes the addition of the EEO Statement and Title IX Statement.

DBB clarifies the college's policy regarding medical examinations of employees.

DDA is a paragraph recommended by TASB as a part of the SACS requirement that colleges maintain job descriptions that are accessible for employees.

DEA adds a sentence that prohibits the district from accepting gifts, grants, donations, etc. to be used a salary supplements.

DEC provides the opportunity for a new biological parent to use college paid sick leave for up to six weeks upon the birth of his/her own child. This policy was already available to employees who are adoptive parents.

DEE adds the requirement for a release for employees approved for international travel. Dr. Israel said the remaining policies incorporate minor edits, title clarifications and/or shifts in language among policy codes.

2014-6-7 Approval to Transfer Funds from the Current Unrestricted Fund to the Building Fund

2014-6-8 Approval of the Transfer of Funds from the Royden LeBrecht Quasi-Endowment to the Foundation

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the transfer of the remaining balance of the Royden Lebrecht Quasi-Endowment in the amount of \$1,581,057 plus accrued interest from the District to the Collin County Community College District Foundation.

President Israel said the funds shall be restricted for Board of Trustees Named Endowed Chair Scholarship (a minimum of three named endowed chair scholarships to be awarded annually for each endowed chair). He also said that the Foundation could get an average of 7% interest through Northern Trust, where the college is getting very little interest, in fact, not enough to generate a scholarship.

On motion of Mr. Rodriguez, second of Ms. Arias, the Board of Trustees of Collin County Community College District unanimously approved the transfer of the remaining balance of the Royden Lebrecht Quasi-Endowment in the amount of \$1,581,057 plus accrued interest from the District to the Collin County Community College District Foundation.

President Israel said the fuel cards are coded to the vehicle and the District will save money on taxes under this program. It is a cost-effective program that provides safety and security.

On motion of Mr. Wainwright, seconded by Mr. Rodriguez, the Board of Trustees of Collin County Community College District unanimously approved the interlocal agreement between Collin County Community College District and Harris County Department of Education providing for a cooperative purchasing program for gas cards for District vehicles (fuel only).

2014-6-12 Approval of Amended Project Plans for the City of Plano TIF #2

WHEREAS, Collin County Community College District ("CCCCD") is an existing participant in the Tax Increment Financing Reinvestment Zone Number Two ("TIF #2) established by the City of Plano, Texas ("City") by Ordinance No. 99-4-23 on April 26, 1999; and

WHEREAS, the City established a Project and Finance Plan for TIF #2 by Ordinance No. 99-8-28 on August 23, 1999, and subsequently amended such Project and Finance Plan by Ordinance No. 2004-2-15 on February 23, 2004; and

WHEREAS, the City and CCCCD entered into that certain Agreement to Participate in the City of Plano Tax Increment Financing Reinvestment Zone Number Two dated August 23, 1999 (the "Agreement"), whereby CCCCD consented to contribute the M&O portion of its tax rate for the captured appraised value of the properties with the TIF #2 zone, subject to its right to approve all additional projects within TIF #2 and its right to withdraw from the TIF #2 at its discretion; and

WHEREAS, by Ordinance No. 2008-11-19, the City amended the Project and Finance Plan to include additional projects and expanded the property within the boundaries of TIF #2; and

WHEREAS, Collin County Community College District consented to the additional projects included within the amended Project and Finance Plan as set forth in Ordinance 2009-11-19; and

WHEREAS, the City has requested the consent of CCCCD for the amendment of the Project and Finance Plan for TIF #2 to include expanding the boundaries of the Zone, extending the term of the Zone for an additional 15 years and providing a severability clause and an effective date as set forth in Ordinance No. 2014-5-15; and

WHEREAS, Collin County Community College District is willing to consent to the amendment of the Project and Finance Plan for TIF #2 upon the conditions set forth herein, NOW THEREFORE,

BE IT RESOLVED, by the Board of Trustees of Collin County Community College District that: 1) consent and approval are hereby given to the revised and amended Project and Finance Plan as set forth in Ordinance No. 2014-5-15 on the express condition that the participation of CCCCD in the City of Plano Tax Increment Financing Reinvestment Zone Number Two will terminate as of December 31, 2014, and 2) tax increments committed to the TIF fund and based on taxes levied prior to December 31, 2014 will be paid by Collin to the TIF fund after December 31, 2014.

Mr. Frank Turner, Deputy City Manager for the City of Plano, thanked the board of its support over the years and said it was important to the revitalization of East Plano. He said the college had been one of four participants in TIF#2; the participation of both the college and Plano ISD will end December 31, 2014. Collin County and the City of Plano will extend for another 15 years. In answer to Dr. Collins' question, Mr. Turner said that under the new agreement the tax base will still be back to the original year of 1999. This will have no effect on the college since it is dropping out.

President Israel said the board continues to abate for historic properties in the cities of Collin County, but that is the only exception.

On motion of Mr. Rodriguez, second of Dr. Collins, the Board of Trustees of Collin County Community College District unanimously agreed that: 1) consent and approval are hereby given to the revised and amended Project and Finance Plan as set forth in Ordinance No. 2014-5-15 on the express condition that the participation of CCCCD in the City of Plano Tax Increment Financing Reinvestment Zone Number Two will terminate as of December 31, 2014, and 2) tax increments committed to the TIF fund and based on taxes levied prior to December 31, 2014 will be paid by Collin to the TIF fund after December 31, 2014.

2014-6-13 Approval of Special Warranty Deed for Struck-off Property

Ralph Hall, District Vice President of Administrative Services/CFO presented the following information reports:

Budget Status Report as of 05/31/14

For the month ending May 31, 2014, expenditures exceeded revenue by \$7,348,784. However, year-to-date revenue exceeded expenditures by \$31,329,720.

Investment Schedule as of 05/31/14

Investments for the month of May totaled \$263,917,755 with TexPool paying .02% and TexStar paying 0.03%. Two Fannie Mae's were paying .12%. The U.S. Treasury benchmark was .03% on May 1, 2014, and .04% on May 31, 2014. Three short-term certificates of deposit with Bank of America are paying .13%, .11% and .11% respectively.

Quarterly Investment Report ending 02/28/14

Since Mr. Hall presents the Investment Schedule monthly, he did not elaborate on the Quarterly Report.

Summary of Foundation Payments to the District 03/14 – 05/14

Foundation payments to the District for the quarter March 2014 through May 2014 totaled \$155,642. Year-to-date payments totaled \$173,579.

Board Announcements:

Chairman Hendricks announced that Andrew Hardin would be the board's representative on Frisco's Tax Increment Reinvestment Zone (TIRZ), replacing Mr. Sam Roach who served in that capacity when he was on the Board of Trustees of Collin College District.

President Israel announced the following:

- 1. Thank you to the Board of Trustees for spending their entire day and evening doing the work of the college. Dr. Israel said the board gave him some challenges to accomplish in the next month or two and he will be bringing recommendations back to the board for discussion. The board held a very productive retreat/work session where it discussed the budget, SACS, policies, strategic planning, and other subjects. He is very appreciative of the board's vision and support.
- 2. President Israel is driving to Austin following the meeting in order to testify tomorrow on a panel with university and community college representatives regarding the RAND study on baccalaureate programs in BSN and cybersecurity. The hearing will last three or four hours and he will brief the board when he returns. The final report is due in September 2014.
- 3. In 2012, Maria Burbano received a Hi-TeCCC transfer scholarship from Collin to the University of Texas at Dallas. This year, she has been awarded the prestigious Goldwater Scholarship and Excellence in Education Program at UTD. Maria was one of 283 students across the nation selected to receive the scholarship from a field of 1,166 top students nominated by university faculty. She is majoring in Biomedical Engineering with focus on biomaterials and plans to conduct research in orthopedic implants and tissue grafts in the industrial setting. Congratulations to Ms. Burbano, Senior Vice President Colleen Smith, Vice President/Provost Mary McRae, Dean Cameron Neal and our Math and Natural Sciences faculty.
- 4. Former Collin College Theatre student Brian J. Smith was nominated for a Tony Award in the category Best Performance by an Actor in a Featured Role in a Play for his performance in the Broadway Show The Glass Menagerie. Although he did not win this year, we are sure this is but the first or many nominations to come for this remarkable young actor.
- 5. We are proud to launch the Fast Track Program in Nursing to enable veterans in our community who have received a medic certification or its equivalent to obtain an associate degree in nursing. Qualifying students can use the credits they earned in the military to receive their associate degree in nursing in as little as three semesters in this accelerated program. We appreciate Senior Vice President Colleen Smith, Vice President/Provost Sherry Schumann, Dean Abe Johnson and Dean of Nursing Donna Hatch for bringing this important program to fruition.
- 6. Collin was well represented at the Texas Society for Respiratory Care Annual Convention in San Antonio where two of our teams competed in this year's Sputum Bowl. Both teams made it to the "final four" competition and ended up being the last
 - two teams standing. As such, they had to compete against each other for the final win. Both teams played exceptionally well. The students who placed first will compete at the American Association for Respiratory Care's Annual Convention in Las Vegas this November. Congratulations to our students, Senior Vice President Colleen Smith,

- Vice President/Provost Sherry Schumann, Dean Abe Johnson, Program Director Araceli Solis, and our respiratory care faculty and staff.
- 7. Congratulations to Professor of English R. Scott Yarbrough on several recent accomplishments. His poem "A Necktie and a Hijab" has been nominated for the Pushcart Poetry Prize, considered the highest national honor for a single work of poetry. In addition, his work has been published and/or reviewed in several industry journals.
