**Meeting Minutes**

August 5, 2014

The Collin County Community College District ("Collin College" or "District") conducted a called meeting of the Board of Trustees on August 5, 2014, in Board Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Dr. J. Robert Collins, Mr. Andy Hardin, Ms. Jenny McCall, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Trustees Stacy Anne Arias and Adrian Rodriguez were not in attendance. Other attendees included District President Cary A. Israel, Collin College administrators and staff.

**CALL TO ORDER**

Chairman Mac Hendricks called the August 5, 2014, meeting of the Board of Trustees of Collin County Community College District to order at 6:20 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas, in Board Room 139.

**ADJOURNMENT TO CLOSED OR EXECUTIVE SESSION**

**2014-8-1-2 Approval of 2014 Calculated Effective Tax Rate and Rollback Rate**

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the 2014 Calculated Effective Tax Rate and Rollback Rate.

On motion of Dr. Collins, seconded by Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the 2014 Calculated Effective Tax Rate of \$0.078965 per \$100 of assessed value and the Rollback Rate of \$0.087092 per \$100 of assessed value.

Chairman Hendricks said the two rates have little to do with anything other than meeting the process that is used for rollback call. He said the figures are calculated amounts from last year's numbers and hard to follow.

**2014-8-1-3 Vote on Consideration of the Proposed Tax Rate for 2014**

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District takes a recorded vote on consideration of the proposed tax rate for 2014.

On motion of Dr. Collins, seconded by Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the recorded vote on consideration of the proposed tax rate for 2014:

Maintenance & Operations Tax Levy	\$0.080000/\$100
Debt Service Tax Levy	<u>\$0.005532/\$100</u>
TOTAL	\$0.085532/\$100

Dr. Collins emphasized that this is a proposed rate and that the board will continue to look at the numbers and analysis/data coming from the Tax Assessor's Office. He said the final tax rate would likely be different when the board gets through with it. The numbers are indicating that the final number will be below the rate proposed and may be the same rate as the District's current rate. Mr. Hardin agreed.

Chairman Hendricks said that between now and the next public hearing scheduled for August 14, 2014, the board will continue to work the numbers. He said the Appraisal District just closed its books on July 25 or 26, so the numbers are very static at this point and new information will be reviewed closely as it is received.

#### **2014-8-1-4 Schedule Two (2) Public Hearings Related to the Proposed 2014 Tax Rate**

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District schedules two public hearings related to the proposed 2014 tax rate.

On motion of Mr. Hardin, seconded by Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved the schedule for two public hearings related to the proposed 2014 tax rate. The first public hearing will be held Thursday, August 14, 2014, at 12:00 noon, at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas in Board Room 139. The second public hearing will be held Tuesday, August 19, 2014, at 6:30 p.m. at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas in Board Room 139.

#### **2014-8-1-5 Bid Report for August 5, 2014**

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves the Bid Report for August 5, 2014.
